Unyielding Hearts: Sexual Indifference in Early Modern English Literature and Religion

In some modern formulations, sexuality occupies an important place in personal identity; sexual desire constitutes a basic component of what makes us human; and sex represents the blissful height of embodiment. To what extent have these modern notions shaped our study of the early modern past? To begin answering that question, this book recovers a culture of sexual indifference in early modern English literature and religion. In particular, it provides examples of sexual aversion, disengagement, and diffidence in the writings of Shakespeare, Milton, Marvell, and the theology of early modern Protestantism. Whereas asceticism restrains sexual desire, often by painful means, the sexually indifferent already possess what ascetics laboriously seek: freedom (if that is the right word) from the body and its erotic urges. In early modern literature and religion, Unyielding Hearts offers a glimpse of human existence unstructured by the assumptions, delights, and constraints of sexual desire. Rather, it seeks to uncover literary representations that are unconstrained, uninflected, and curiously aloof from the compulsive sexualities of modernity. (In progress)

Early Modern Asceticism: Literature, Religion, and Austerity in the English Renaissance

This book demonstrates the post-Reformation relevance of asceticism in early modern England. In chapters on John Donne, John Milton, Andrew Marvell, and John Bunyan, it argues that conflicting approaches to asceticism inform literary depictions of sexual desire, subjectivity, and sexual renunciation (University of Toronto Press, 2019).
